1. Manuscripts written in one of the congress languages, but preferably in English, should be submitted in duplicate to: Editorial Office, Institute of Mathematics, Silesian University, Bankowa 14, 40-007 Katowice, Poland. The manuscripts will not be returned to the authors, so they are advised to retain an additional copy.
2. An abstract of no more than 20 lines, key words, and AMS subject classification should be included. Symbols should be as simple as possible (consult Manual for authors of mathematical papers in the Bulletin of the American Mathematical Society, Volume 68, Number 5, 1962). For bibliographic references please follow the style and abbreviations used by the Mathematical Reviews.
3. To speed up the publication process the authors are requested to provide the .tex file of their manuscripts (*TEX*, *LaTEX* or *AMS-TEX* are acceptable). E-mail addresses should also be included in the manuscript.
